November 16, 2021: Anvil Capital of Boston MA, has completed the acquisition of Lynch Landscape & Tree Service, Inc of Sudbury, Massachusetts, marking its seventeenth deal across seven portfolio companies. The transaction was structured as an add-on acquisition for NE Landscape Holding, a portfolio company of Anvil Capital and Spring Capital. Funding for the transaction was provided by Salem Five Bank. Terms of the acquisition were not disclosed.

Founded in 1980 by Mike and Kelleigh Lynch, Lynch Landscape is a leading residential landscaping company with a service area primarily focused on the Boston Metro West towns of Sudbury, Weston, Wayland and Wellesley. Mike Lynch commented “I wanted to find an exit that would provide the right long-term solution for my customers and employees. Anvil Capital and NE Landscape approached me with a great structure, providing meaningful liquidity upfront while still retaining some equity for future upside. Also, I will continue to be involved in the business. Most importantly, my customers and employees will be taken care of.”
